**Karting and/or Paintball and/or Laser Combat, hereinafter referred to as "activity"****ACCEPTANCE OF RISKS:**

1. I am aware of the nature of the events and activities and accept and acknowledge, freely and voluntarily, that there are risks inherent to participation in the activity, in particular the risk of property damage, non-monetary damage and/or physical harm, even death, resulting from, among other things, possible defects in the equipment used during the course of the activity, falls caused by obstacles located on the race course, physical exertion while participating in the activity, an accident caused by or brought about by a collision between one or more karting, and entering and circulating in the dedicated areas for whatever reason and with authorization; and
2. In spite of exposure to these risks, in particular those listed above, I wish to participate in the activity and thereby assume the risks I expose myself to in so doing; and
3. I hereby attest that I am in good health and that I am not suffering from any illness or injury that could be aggravated by engaging in the activity; and
4. Equipment, protective clothing and all necessary or useful accessories allowing me to engage in this activity were provided to me upon my arrival, are in good condition, and appropriate for these uses; and
5. The safety instructions have been explained to me, namely but not limited to: I must not be under the influence of drugs or alcohol when I participate in PAINTBALL and/or LASER COMBAT activities, I must not pick up balls from the floor, run on the field, slide under vehicles, enter the cockpit, fight with others, climb and/or jump on obstacles, fire aimlessly and/or use balls other than those provided by Action 500; I must keep my mask on at all times while on the field and use a barrel cover on my paint gun when I am off the field; I must not be holding a telephone when I am participating in a KARTING activity, I must not be under the influence of drugs or alcohol, I must avoid wearing coats, scarves, loose clothing, open-toe or high-heeled shoes, I must remain seated in the kart at all times, I must avoid all contact with engines and tailpipes, I must avoid contact between karts, I must reduce my speed when an employee of Action 500 waves a yellow flag and/or activates the yellow lights on the track, I must tie my hair back if it is long and avoid getting into a fight; and
6. I have read the notice posted in the entrance stipulating that ACTION 500 is exempt from liability resulting from non-monetary damage, bodily harm or property damage, and I understand that this notice serves as a warning of the danger in participating in the activity;
7. I completely understand that all of the rules related to participation in the activity must be strictly followed and that I will be solely responsible for my personal safety at all times; and
8. I understand that it is my responsibility to remove myself immediately from the activity and advise Action 500 representatives if, at any time, a dangerous or unsafe situation presents itself or my protective clothing, accessories and equipment are damaged; and
9. I attest that I am at least 18 years old or that I am the legal parent or guardian of the participant.

**I UNDERSTAND AND ACKNOWLEDGE THAT SIGNING THIS DOCUMENT CONSTITUTES:**

10. ACCEPTANCE AND ASSUMPTION OF ALL THE RISKS associated with or inherent to my participation in the activity, including non-monetary damages, property damage and/or bodily harm; and
11. A WAIVER OF LIABILITY AND RELEASE FROM ANY CLAIM OR CAUSE OF ACTION implicating in any way ACTION 500 and/or any person acting on its behalf for all bodily harm, property damage and/or non-monetary damages resulting from my participation in the activity; and
12. ACKNOWLEDGEMENT that this commitment must be interpreted pursuant to applicable laws of the province in which the commitment is signed;
13. Acknowledgement that I HAVE READ THIS DOCUMENT IN ITS ENTIRETY.
